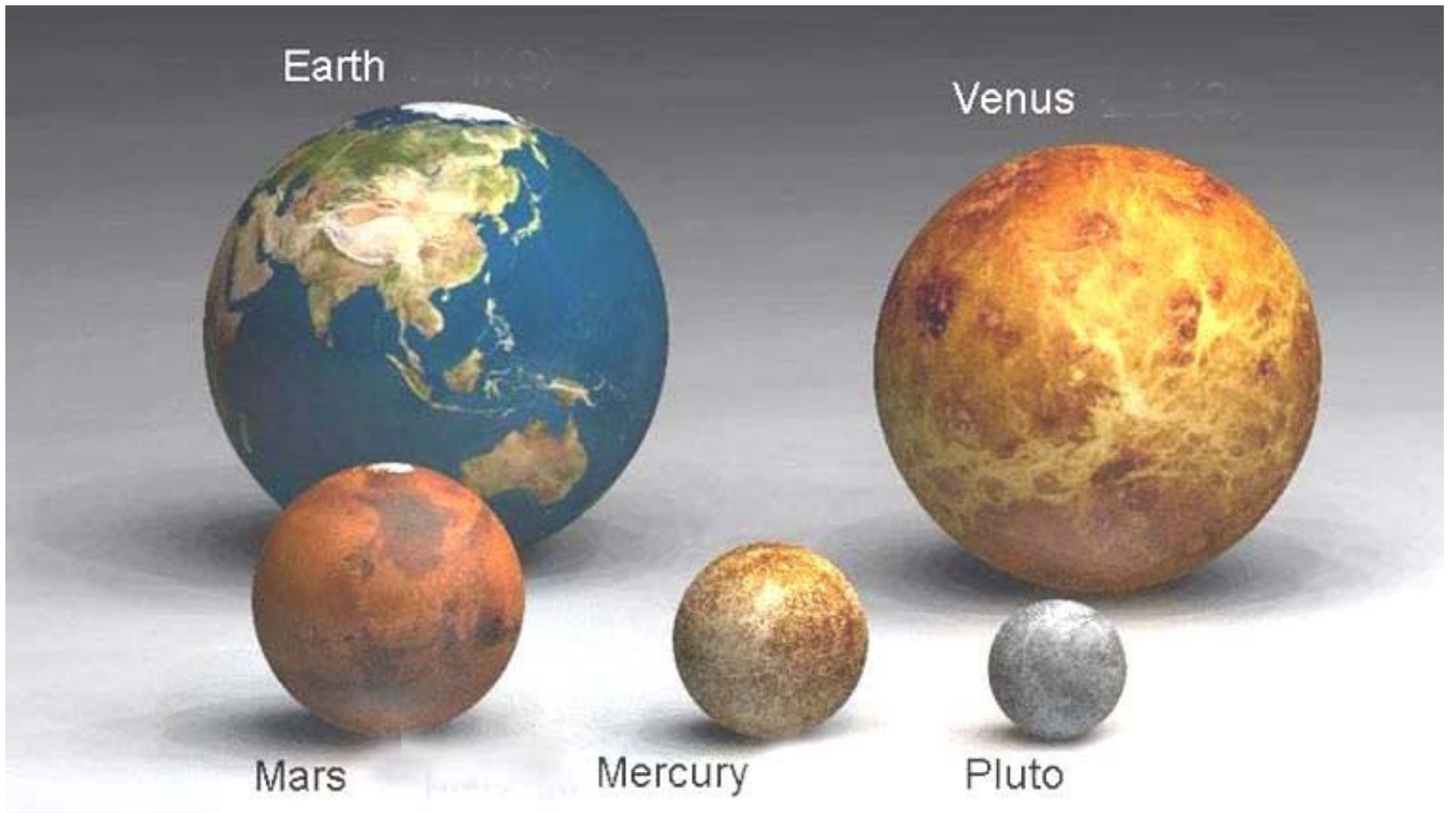

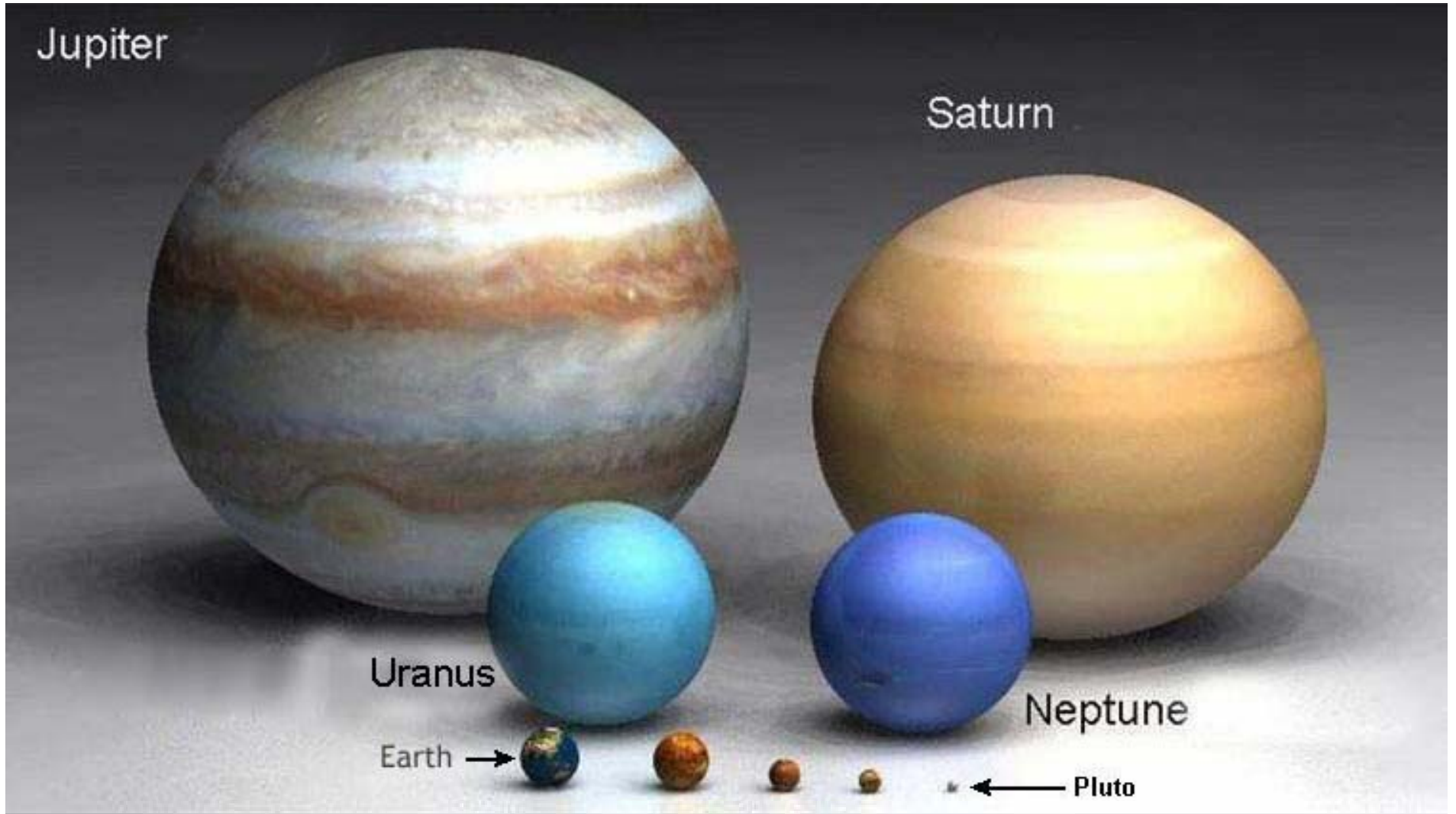

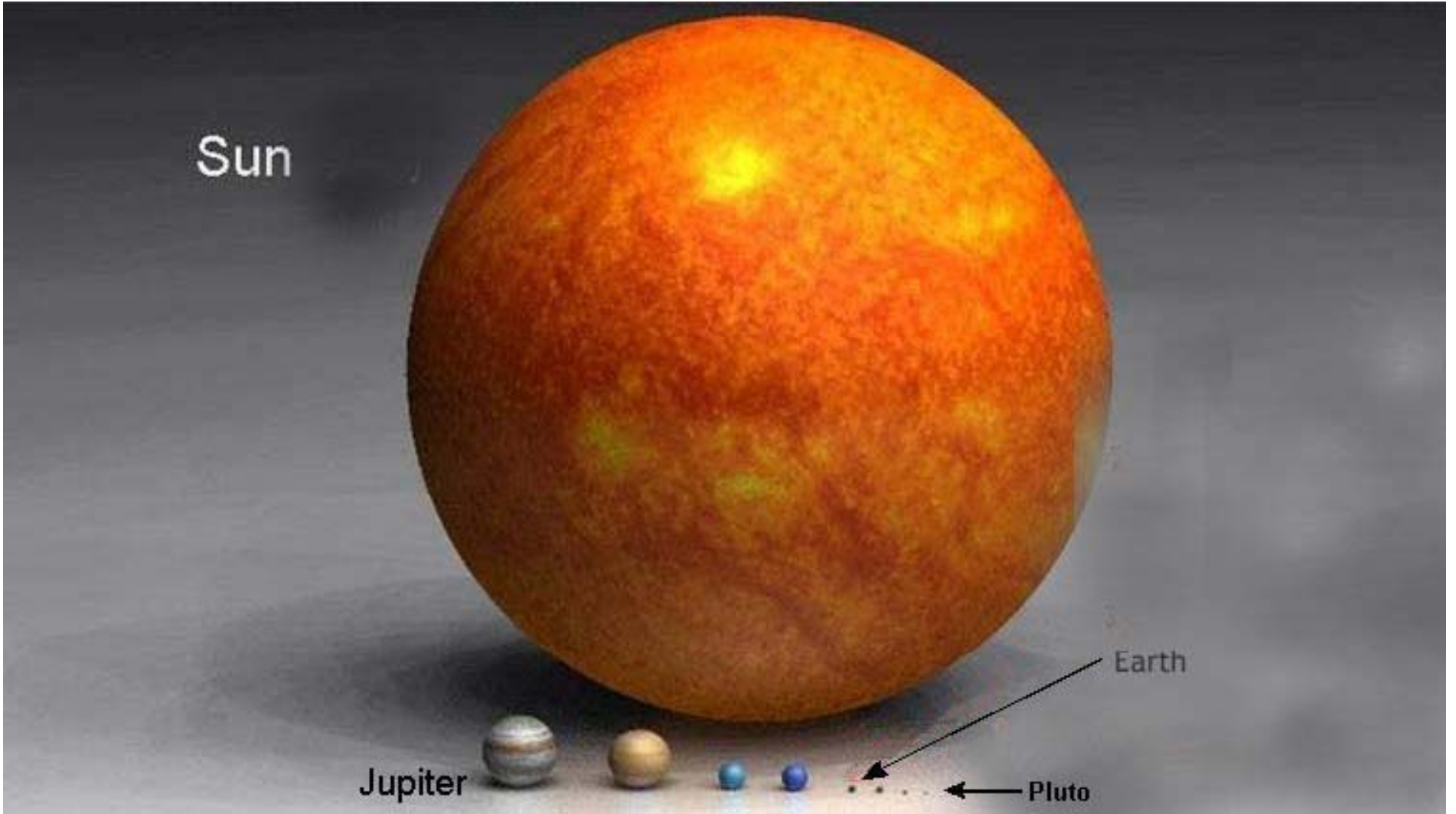
Sovereignty - Complete independence and self-government.

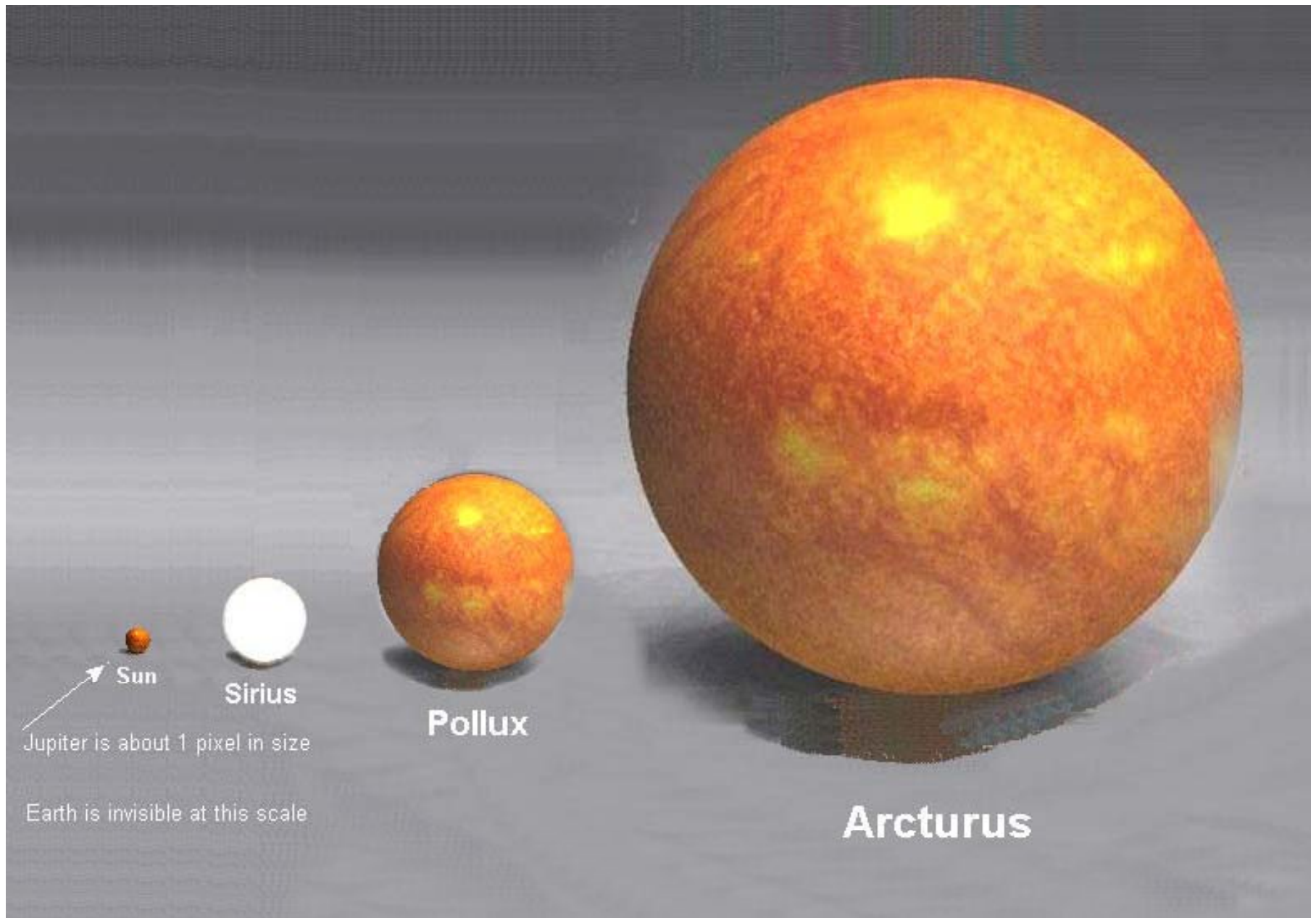

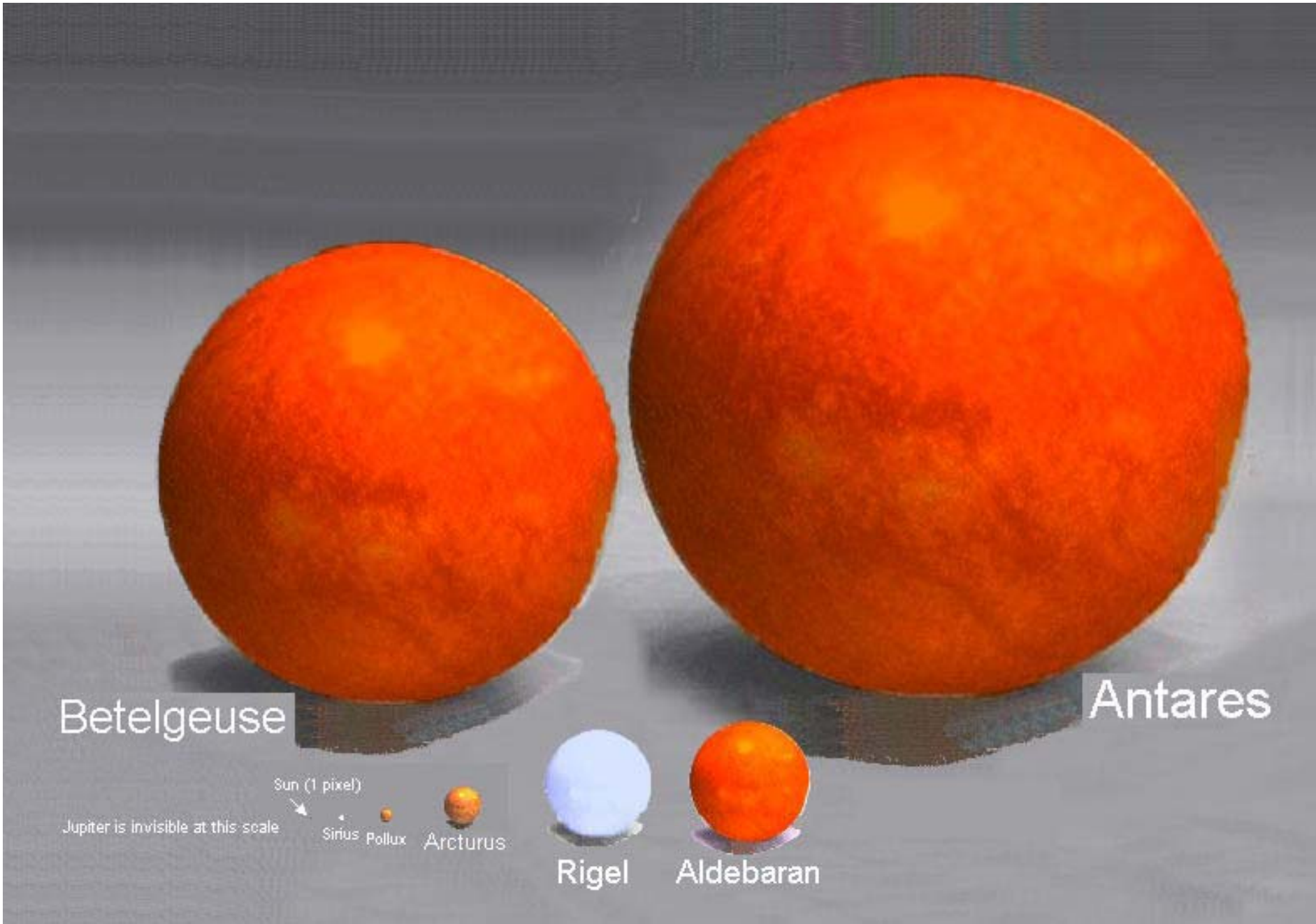

OK Enumerated Powers Act failed to get out of the House by a vote of 34-60 on 3/10/10. There are 62 Republicans in the House, most of whom campaigned for limited government.

Brent Scowcroft – OU Conference

OU held a conference, “A New Kind of Leadership: America and the Rise of the Rest,” that included keynote speakers Leon Panetta, CIA director, and Zbigniew Brzezinski and Brent Scowcroft, former national security advisers.

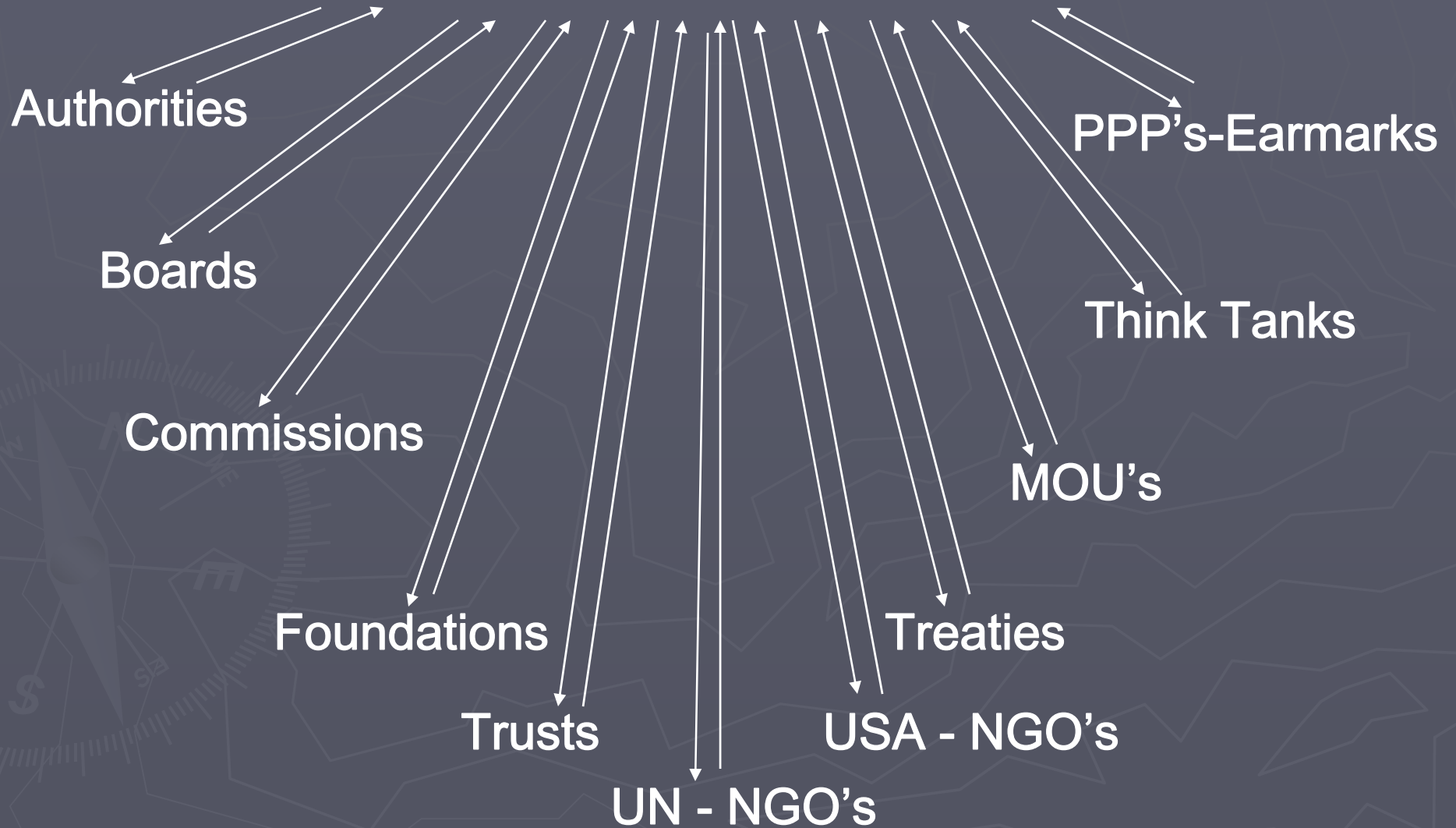

Former Oklahoma Governor Frank Keating – 2009

In the end, Keating encouraged legislators to remember that “the public sector consumed wealth while the private sector creates wealth.” He called for a careful review of “what government does, and whether those things can be done better in the private sector.” He argued it is time to enhance , not erode, the role of states as laboratories for experimentation in democratic decision-making, explicitly encouraging a fight or two over the meaning of the Tenth Amendment and its protections for state governments. “we may need to litigate to defend the state of Oklahoma,” Keating said - **November 2009 Speech to State Chamber members**

Kentucky & Virginia Resolutions of Nullification -1798

Here, in brief, is the essential statement of the principles behind nullification. The states had not agreed to a system in which they would submit without protest to whatever the federal government should do. To the contrary, the states established a federal government with limited powers, and reserved for themselves all powers they did not delegate to that government. Any measures the federal government should take beyond the powers delegated to it are absolutely void.

Kentucky & Virginia Nullification Resolutions -1798 Continued

The federal government, which the states themselves created, cannot hold a monopoly on constitutional interpretation and cannot decide for itself what the extent of its own powers are. That would mean the people were governed by the mere discretion of the rulers rather than the Constitution. Since the federal government, either as a whole or in its branches, is not and cannot be an impartial arbiter of disputes between itself and the states of which it is composed, it is up to each state's own judgment to decide when the Constitution has been violated and how that violation is to be addressed.

Supreme Court Decision Printz, Etal vs. United States - 1997

“The Federal Government,” we held, “may not compel the States to enact or administer a federal regulatory program.” “The constitutional line is crossed only when Congress compels the States to make law in their sovereign capacities.” “Much of the Constitution is concerned with setting forth the form of our government, and the courts have traditionally invalidated measures deviating from that form.”

Printz, Etal – con't

“The result may appear ‘formalistic’ in a given case to partisans of the measure at issue, because such measures are typically the product of the era’s perceived necessity. But the Constitution protects us from our own best intentions: It divides power among sovereigns and among branches of government precisely so that we may resist the temptation to concentrate power in one location as an expedient solution to the crisis of the day.”
