8-STEP ACTION PLAN

Action Steps

1. Make copies of the Open Letters on pages 6 and 7 and mail them to each of your federal and state senators and representatives - with a one-page letter from you, typed or neatly handwritten, attached in front of the Open Letter – or draft your own letter with the same requests as found in the open letters. The focus of the open letters is to request that our senators and representatives:

- Defund the Security and Prosperity Partnership (SPP) activities by our federal government.
- Stop enactment of the Public-Private Partnership legislation in Oklahoma. (Such legislation has already passed in 23 states! Oklahoma must not be #24.)
- Withdraw Oklahoma from membership in NASCO (North America's SuperCorridor Coalition)

Because elected officials receive a <u>huge</u> amount of email, a mailed letter will have much more likelihood of being read than an email. A mailed letter says, "I care enough to invest more time than a quick email." <u>Be sure to include your voting address so they know you are a constituent.</u> For federal office holders, mail your letter to a district office instead of their Washington office, where it's likely to get buried among the hundreds of letters typically received at that office. *(If you have one, include your email address they can use to expedite their reply.)*

- 2. If you have email capability and have not received a reply within10 days of the date you mail your letter, email them a brief follow-up or simply call their office and ask when you might expect a reply.
- **3**. Arrange an appointment with your federal and state senators and representatives to discuss your concerns personally. <u>No other action has more impact!</u> See them when they are available as close to your home as possible, usually during congressional recesses.
- 4. Continue to inform yourself and others about these issues. Pick up copies of the resource materials from the OK-SAFE table at this conference. From <u>www.ok-safe.com</u> you may also download copies of this booklet and the materials at the OK-SAFE table you can forward to other in your "circle of influence". (We need to inform as many citizens as possible!)
- 5. Please ensure OK-SAFE has your email address or home address and phone number so we may contact you with timely information, alerts, and suggestions for additional actions you can take.
- 6. Consider joining or donating to OK-SAFE, Inc. (Donations are not tax-deductible.)
- 7. Attend monthly OK-SAFE "Town Hall" meetings held at the Hardesty Regional Library, 8316 East 93rd Street, Tulsa on the first Tuesday of the month from 6:45 pm to 8:00 pm. and invite others.
- 8. Order copies of the DVD of this conference and distribute to your elected officials and others.

ON the Trans-Texas Corridor and NAFTA Superhighways

The NAFTA Superhighway 'Memory Hole', by Debra Niwa, Expert Researcher, 2007. The "NAFTA Superhighway" label surfaced shortly after the signing of the North American Free Trade Agreement (NAFTA). Concepts and activity connected to "NAFTA Superhighway" exist today under "NASCO SuperCorridor" — this includes:

- 1) establishing an international highway/corridor system that incorporates an Information Technology System (ITS)

 (government + business partnering helps overcome obstacles like public dissent)

- 7) promoting "smart highways/corridors" which coincidentally requires the same technologies as a continent-wide surveillance/monitoring system would use:
 - surveillance equipment (electronic readers, sensors, scanners, cameras...)
 - technology for transmitting data (fiber optic cable networks, wireless communications, etc.)

NASCO, in partnership with SAVINetwork (a Lockheed Martin/Chinese partnership), plans to track the movement of goods from Asia through an International Trade Corridor from Mexico to Canada passing through Oklahoma and America's Heartland by implementing a Global Trade Corridor Management system.

Public/Private Partnerships with U.S. and international corporations, used to fund Transportation infrastructure, grant contract monopolies containing egregious terms such as tax breaks, non-compete clauses, revenue escalators, generational leases and exclusive site locations.

NASCO Trade Corridor Management Systems, Mexican Trucks, Trans-Texas Corridor, and Foreign Landlords all threaten Oklahoma's Sovereignty, Safety and economic well-being.

Accordingly, we request:

- Oklahoma be withdrawn from NASCO membership;
- Public/Private Partnership legislation be rejected; and
- Oklahoma competitive bidding Law be strengthened.

How to Make Your Letters to Capitol Hill Count

A Citizen Action Manual by The John P. McGovern M.D. Center for Environmental and Regulatory Affairs

Letters to policy makers -- whether they be to Members of Congress or other officials -- can be an effective means of influencing public policy. Some letters, of course, are more effective than others. To follow are some tips on making your correspondence with policymakers as effective as possible:

Have a Specific Message. Make sure to have a specific action request before you write. If you want a decision changed, a vote cast a particular way or to communicate specific facts, be clear and concise. For legislative action, be sure to include the name and bill number of the legislation you are advocating (i.e., the America Loves Dogs Act, H.R. 1). Ask for a specific, detailed reply, and be prepared to write a second time if you receive a response that is vague.

Be Brief. Your letters are more likely to be read if they are brief and to the point. Include one or two arguments for your position -- presumably, those arguments in which your opinion would be given particular weight by virtual of your position or those that are simply powerful on their own merits.

Target Your Letters. Elected officials -- particularly federal office holders -- seldom read their own mail. This duty normally falls to a staffer -- often one with little influence over policy decisions. To increase the chances that your letters will have impact, make sure to direct them to staff members who have some responsibility for issue(s) in question. For letters to Congress, these individuals will most often be Legislative Assistants or Legislative Directors. <u>You may also wish to consider sending letters to your Congressman's or Senators' district offices rather than their Washington, D.C. offices. Washington offices are inundated with mail, while district offices are not. As a result, a dozen letters in support of a particular position can be perceived as a ground swell of public support, while hundreds of letters to a Washington office would scarcely be noticed.</u>

Personalize Your Letters. Although mass-produced postcards and letters can demonstrate to policy makers that a large group of people hold the same point of view, individually written postcards and letters are much more effective. A policy maker knows the letter-writer is genuinely concerned about an issue when he or she has taken the time to write a personal letter.

E-Mail Has Limitations. Policymakers know that emails are easier to send than letters, so many take them less seriously. If, however, email is all you have the time or inclination for, be sure to include your name, home address and phone number on the email. As with physical mail, personally-written, thoughtful and courteous messages will be more effective than mass-produced, superficial and/or hostile messages. Also, be aware that some officials, particularly on the federal level, receive so many emails that only those that come from constituents are reviewed.

Be Timely. If you wish to influence a policy maker's opinion on a specific issue, write early. Your letters will be most effective if sent before the official has developed an opinion.

Be Courteous. Rude comments in your letter will make it less effective. One can be firm while being courteous.

Follow-up. If you receive a vague response from an elected official, write again and request more specific information. And, should the policy maker do as you ask, make sure to send a thank you. Thank you letters are rare and thus most appreciated.

Utilize Letters-to-the-Editor and Op/Eds. If you get a letter-to-the-editor or an opinion editorial published, send a copy of it with your letters to elected officials. This will show policy makers that you are more than casually interested in the issue, that you have credibility, and, most important, that you have influence in the community.

Sign Your Letters. Include your name, address, telephone number and, if you have one, your email address in your letter, so policy makers can respond easily.

Type or Print. Make sure your letters are legible -- preferably typed. If that is not possible, they should be printed neatly.

RECENT DEVELOPMENT

On August 6, 2007 22 U.S. Representatives sent a letter to President Bush - in advance of his attending a third annual Security and Prosperity Partnership Summit with his counterparts from Mexico and Canada. The key comments contained in their letter are:

"The House of Representatives last week overwhelmingly and on a bipartisan basis by adopted an amendment barring Transportation Department officials from participating in SPPrelated meetings in the future. This vote is an indication of the serious concerns felt by those of us in Congress and by our constituents about this initiative – concerns that will only be intensified if pursuit of the SPP continues out of public view and without congressional oversight."

"The SPP process, however, is being conducted in a secretive manner with a view to 'harmonizing' U.S., Canadian and Mexican policies, regulations and practices in ways that may actually undermine our security and sovereignty. ... Such secretiveness seems not to be accidental. The public interest group Judicial Watch had to resort to use of the Freedom of Information Act to obtain notes from a "North America Forum" conference, attended by U.S government and corporate officials.

Conferees made reference to using a practice called "evolution by stealth" to prevent significant opposition from developing to the desired end-state: a supranational North American association of some kind."
